CHAPTER - 1

INTRODUCTION

1.1. BACKGROUND

- 1.1.1. Following the recommendations of the Working Group in the Third Five Year Plan for Small Scale Industries, the Government of India had decided to set up an autonomous institution. Accordingly, "Central Industrial Extension Training Institute (CIETI)" was created in Delhi, in October 1960, as a Department of the Central Government under the Ministry of Commerce and Industry. The main objective was to provide training to the personnel of the Central Small Industries Organisation as well as of the departments of industries of the State Governments.
- 1.1.2. In 1962, in pursuance of Resolution No.27-SSI(C) (6)/62 dated 30th July 1962 of the Ministry of Commerce and Industry of the Government of India, the CIETI was shifted to Hyderabad and converted into an autonomous **institution**, registered under the Hyderabad Societies Registration Act No.I of 1350 Fasli in the name and style of "Small Industry Extension Training (SIET) Institute", Hyderabad. All the functions of the CIETI were, with effect from the forenoon of 1st July 1962, taken over by the "Small Industry Extension Training Institute" and the CIETI ceased to function as a Government Department from the afternoon of the 30th June 1962.
- 1.1.3. Consequent upon conferment of national status on the Institute by the government of India, SIET Institute was re-named as "National Institute of Small Industry Extension Training" (**nisiet**) with effect from 28th September, 1984. In the same year, UNIDO had recognised the Institute as Centre of Excellence.
- 1.1.4. Pursuant to the enactment of MSMED Act, 2006, the name of the Institute was again **changed** as "National Institute for Micro, Small and Medium Enterprises" (**ni-msme**) with effect from 11th April, 2007.
- 1.1.5. The objectives for which the **Institute** was established were promotion and development of micro, small and medium enterprises and enhancement of their competitiveness through the following activities:
 - to provide, supervise and plan training for persons engaged in MSME development and management activities
 - to undertake, sponsor or plan research programmes related to the development of MSMEs, and
 - to enter into and execute technical agreements and assistance with international or other organisations for the provision of services for the development of **MSME** sector
 - to offer and organise educational programmes in the promotion of micro, small and medium enterprises
- 1.1.6. The vision of the Institute is to emerge as a global centre of excellence for creation, sustenance and growth of MSMEs and to impact the growth and development of MSMEs through services in the areas of policy, entrepreneurship, technology, information, education, management and extension.

1.2. ORGANISATIONAL SET UP

- 1.2.1. The Hon'ble Minister of State for MSME (Independent Charge) is the President of the Society and the Secretary to the Government of India, Ministry of MSME is the Vice-President of the Society. Fifty meetings of the Society have been held so far.
- 1.2.2. The management of the Institute rests with the Governing Council and the Executive Committee, appointed by the Government of India.
- 1.2.3. The Hon'ble Minister of State for MSME (Independent Charge), Government of India is the Chairman of the Governing Council; and the Secretary to the Government of India, Ministry of MSME is the Vice-Chairman. The Governing Council is composed of 21 ex-officio and nominated members.
- 1.2.4. The Secretary to the Government of India, Ministry of MSME is the Chairman of the Executive Committee and the Additional Secretary and Development Commissioner (MSME) is the Vice-Chairman. The Executive Committee acts through the Director General, who is the academic and executive head of the Institute. The Executive Committee consists of 9 ex-officio and nominated members.
- 1.2.5. The Director General is the Head of the Institute and the Member-Secretary of the Executive Committee and the Governing Council. He is assisted by the Directors of the Schools and the Registrar in respect of academic matters and the Chief Administrative Officer in overall administration and general administrative matters.

1.3. Statutory Meetings

1.3.1. The 5th Annual General Meeting of **ni-msme** Society was held on 5th December, 2012. The meeting was presided over by the President of the Society, Hon'ble Minister of State for MSME (Independent Charge), Govt. of India. The Annual Report together with the audited statements of accounts for 2011-12 were approved and adopted.

- 1.3.2. The 6th meeting of Governing Council was held on 5th December, 2012 in New Delhi under the Chairmanship of the Hon'ble Minister of State for MSME (Independent Charge), Govt. of India.
- 1.3.3. Two meetings of the Executive Committee were held during the year: the 10th meeting on 1st July, 2012 and the 11th meeting on 26th November, 2012, both in New Delhi.

1.4. NEW DIRECTOR GENERALASSUMED CHARGE

1.4.1. Consequent upon selection, the Government of India, Ministry of MSME, New Delhi vide Order No.A-30011/08/2010-Estt dated 12th April, 2012, appointed Shri M. Chandrasekhar Reddy as Director General of the Institute. He assumed charge of the post on 12th April, 2012 (AN).

1.5. SCHOOLS OF EXCELLENCE

1.5.1. In acceptance of the recommendations of the Staff Inspection Unit, Department of Expenditure, Ministry of Finance, Government of India, as also the Peer Review on the activities of the Institute, the existing Centres and Cells were formed into four theme-focused Schools which, as attachments, have twelve Centres and five Cells functioning cumulatively, yet each pursuing activities specifically focused on one fact of MSME domain, designing tailor-made, collaborative programmes for the benefit of client organisations, entrepreneurs, association leaders, government officers, bureaucrats, public-private-partnership company executives, trainers and so on.




Fig: Functional Spectrum

1.7.5. The faculty at **ni-msme** is knowledge-rich with accrued experience and tested expertise, lending the edge of quality to the specialised and innovative training programmes, seminars and workshops organised by the Institute.

1.8. PROGRAMMES AND OTHER SERVICES

1.8.1. Announced National Programmes

- 1.8.1.1. **ni-msme** offers and conducts regular training programmes for the development of MSMEs within the country, as well as in other developing countries. The regular programmes range from one week to 12 weeks, in different disciplines, to suit the requirements of client organisations.
- 1.8.1.2. Information Technology programmes for the educated unemployed youth are being conducted to build up their IT skills. IT programmes are also conducted for the benefit of employees/executives of the sponsoring organisations.

1.9. Sponsored National Programmes

Training programmes are also conducted at the request of client organisations, as per their needs. Programmes are conducted on-campus and off-campus. Entrepreneurs/industrialists are tapped in the customised off-the-campus programmes at the sponsorship or initiative of the Small Industry Associations of different districts/States or other organisations, at client-preferred locations.

1.10. Seminars and Workshops

Seminars and workshops on different subjects, in accordance with the Government policy towards the MSME sector, are also conducted on the campus and off the campus.

1.11. Announced and Sponsored International Programmes

Long-term programmes are offered and conducted to suit the needs of the developing countries. Customised programmes at the request of sponsoring organisations like CFTC, MEA, ILO and UNIDO, BSCIC, ARB Bank (Ghana), and the Central Bank of Srilanka are also conducted.

1.12. Research & Consultancy

- 1.12.1. **ni-msme** has long and considerable experience in conducting research studies, which has contributed significantly to accomplishing its objectives. The research projects so far taken up are multifaceted, dealing with micro and macro aspects of small enterprise management, extension, development and promotion.
- 1.12.2. With long experience in conducting a wide variety of studies relating to assessment, evaluation, impact, problems, identification diagnostic and problem solving approaches, behavioural aspects, marketing and other managerial aspects, modernisation, technology transfer, etc., **ni-msme** continues to serve its clientele through its research activities.

1.13. Information & Library Services

- 1.13.1. **ni-msme's** Small Enterprises National Documentation Centre (SENDOC) has been suitably strengthened to provide a comprehensive database on domestic as well as international business opportunities, trade enquiries, regulatory systems, etc., of value to the MSME entrepreneurs. Such database services are also offered on-line to MSME associations in the country.
- 1.13.2. The Institute's Library services are utilised by a large number of members during the working hours as well as before and after office hours.

1.14. Publications

ni-msme publishes the research quarterly SEDME journal as part of its academic activities. The Institute also publishes books in manuals related to different aspects of MSMEs which supplement the training inputs. Besides it also brings out a monthly news bulletin reviewing its activities during the previous month.

1.15. CAMPUS AND FACILITIES

1.15.1. Set amidst a sprawling, serene campus, **ni-msme** is ideally located for academic and training pursuits. Natural and peaceful surroundings, perfect landscaping and lush greenery compete with each other to help the participants relax in mind and body. Spacious and ultra-modern air-conditioned classrooms and conference halls with state-of-the-art instructional and functional gadgets, computers with specific software for cutting edge IT courses; advanced laptops and other instructional tools make learning at **ni-msme** a pleasant pursuit. The infrastructure at the Institute includes:

1.16. Guest Room Complex

- 1.16.1. Clean and comfortable guest rooms that can accommodate over 250 guests, with modern amenities and facilities on par with international standards, clean and hygienic cuisine make the Institute's hostel complex a home away from home for the participants. The attached hospitality wing has the following features:
 - Multi-cuisine mess with 3 dining halls
 - Accommodation 130 rooms to accommodate 260 persons

- Guests and participants are accommodated in a/c or non a/c rooms, with suites for VIPs and dignitaries.
- All rooms are provided with TV, Wi-Fi, and telephone.

1.17. Sports and Games

1.18.2. MUSINGS is another ideal outdoor location in the campus, set amidst tall trees with a pond, best suited for get-togethers. UTSAV, VANASTHALI and PRERANA are other ideal locations for outdoor and indoor meetings and social gatherings.

1.19. Herbal Vista

- 1.19.1. Pursuant to the efforts of the Institute the A.P. State Medicinal and Aromatic Plants Board, Government of Andhra Pradesh, Hyderabad had sanctioned a grant of Rs.20.00 lakh, of which Rs.12.00 lakh was released during the year for the purpose of development of a herbal garden in the campus.
- 1.19.2. The work relating to the herbal garden, which was named as 'Herbal Vista', opposite to the B-Block in the campus, is in progress. The Herbal Vista was inaugurated by Shri C.K. Mishra, IAS, Joint Secretary (SME), Ministry of MSME on 14th March, 2013.



1.23. The organizational structure





CHAPTER - 2

GROWTH AND PERFORMANCE

- **2.1.** The National Institute for Micro, Small and Medium Enterprises, since its inception as Small Industry Extension Training Institute, was dependent on the Government of India in meeting its recurring and non-recurring expenditure every year.
- 2.1.1 Pursuant to the recommendations of the 5th report of the Expenditure Reforms Commission and the directives from the Government of India, the Institute entered into new avenues of income sources and such efforts helped the Institute become self-supporting from 2001-02 in meeting its recurring expenditure every year. However, grants for specific purposes for meeting expenditure as one time grant and financial assistance at pre-determined hourly rates for conducting entrepreneurship and skill development programmes under the Scheme of Assistance to Training Institutions (ATI) of the Ministry are being extended.

2.2. PHYSICAL PERFORMANCE

2.2.1. The total number of programmes conducted and participants trained; and research and consultancy projects executed during 1962-63 to 2012-13 are indicated in the following table.

2.2.2. The number of participants trained includes 8,000 executives from 134 different developing countries, who had attended the International programmes conducted exclusively for the nominees sponsored under TCS of Colombo Plan and ITEC/SCAAP of the Ministry of Finance and Ministry of External Affairs, apart from international funding agencies.

- 2.2.3. The year 2012-13 has witnessed an increase by 82% in the programmes and by 91% in the number of participants. The major increase was in the national sponsored programmes (385%), which was on account of certification of trainees of SETWIN-conducted skill development programmes. The National announced programmes had also recorded an increase of 58% over the previous year. However, there was a decline in the research and consultancy projects as the anticipated projects from different Ministries/Departments did not materialise.
- 2.2.4. The physical performance for the year 2012-13, compared with the previous year, is indicated in the following table.




Graph 1: Programmes 2012-13 & 2011-12

2.3. FINANCIAL PERFORMANCE

2.3.1. A 59% growth has been achieved in the income of the Institute from its various activities: from Rs.2,168.08 lakh in 2011-12 to Rs.3,441.66 lakh for 2012-13. This was possible on account of the efforts of the Institute in conducting not only innovative programmes but also executing more programmes than in the previous year.




Graph 3: Activity income

CHAPTER - 3

SKILL DEVELOPMENT PROGRAMMES UNDER ASSISTANCE TO TRAINING INSTITUTIONS (ATI) SCHEME

3.0. SCHEME OF ASSISTANCE TO TRAINING INSTITUTIONS

- 3.1. The Ministry of Micro, Small and Medium Enterprises promotes the development of micro and small enterprises in the country with the objective of creating self-employment opportunities and upgrading the relevant skills of existing and potential entrepreneurs. In order to promote the establishment of new enterprises and creation of new entrepreneurs the Ministry has been implementing various schemes and programmes.
- 3.1.1. As part of such schemes, the Ministry had launched during the last quarter of 2009-10 a new scheme, "Assistance to Training Institutions", in order to ensure that young entrepreneurs are encouraged and suitably equipped to take up new ventures, by imparting to them entrepreneurship and skill development training through three national level Entrepreneurship Development Institutes.
- 3.1.2 National Institute for Micro, Small and Medium Enterprises, one of the three national level Entrepreneurship Development Institutes, has been playing a major role, as APEX Institution of the Ministry in the implementation of this scheme.



3.1.4. The Ministry had approved and allotted 1,292 programmes, against which 433 programmes were actually conducted through Partner Institutions covering 12,286 beneficiaries; and 539 programmes covering 16,157 beneficiaries were conducted by the Institute itself. As against the total financial assistance involved of `2,318.53 lakh, assistance released by the Ministry was `1,441.07 lakh and the balance of `877.46 was due to be released as on 31st March, 2013.

3.2. Success Stories

- 3.2.1. Dealership in Solar Equipment
- 3.2.1.1. Mr. Satish Kumar, Son of Mr. M. Sanamallaiah is the native of Sathegala village located in Kollegal taluk of Chamarajanagar district of Karnataka. His parents were retired government employees. Mr. Satish has completed his B. Tech in Mechanical Engineering and worked in M/s RK Solar Power Systems Pvt. Ltd., for about 15 years. After getting this experience, he thought of starting his own business in the same field. He applied for a loan under PMEGP through the DIC. Unfortunately, he could not succeed in his mission. Later, he came to know from the DIC that the Government of India is implementing the PI scheme through which EDP and skill development trainings are being provided to unemployed youth free of cost. Then he contacted ni-msme, Hyderabad and was directed to AWAKE, Bangalore, as this organisation was implementing the scheme as one of the Partner Institutes of ni-msme. Mr. Satish joined the EDP conducted by AWAKE. After completion of 12 days EDP training course, he gained knowledge in marketing techniques, institutional and credit support, project report preparation, taxation and other regulations for setting up of small scale enterprises and also felt confident of starting the business once again.
- 3.2.1.2. Mr. Satish started his own business by taking dealership for the products of the company M/s EMVEE SOLAR Systems Private Limited, one of the leading manufacturers of solar devices in India. Since then, he has been doing well with guidance from AWAKE. He employed 3 persons in his business. His monthly income is Rs.15,000/- per month excluding expenditure.

3.3. Tea Powder Packing Unit

- 3.3.1. Ms. Suchitra Devi aged 40 hails from Vijayawada, Andhra Pradesh. She came to know about the ESDPs conducted under the PI Scheme through the advertisement given by the Centre for Entrepreneurship Development (CED), Hyderabad, a Partner Institute to **ni-msme**. She then contacted the local coordinator at Vijayawada and after the counselling process she joined the ESDP in Food Processing at the Vijayawada Training Centre of the CED.
- 3.3.2. She participated in the ESDP conducted during 12 Nov 20 Dec 2011. She was given orientation on self-employment opportunities in food processing, EMT, enterprise creation, support services and other aspects relating to starting self employment venture in food processing. After the training, Ms. Suchitra gained confidence to start a trading unit M/s VNR Traders for distribution of tea powder in the ALEAP Industrial Estate. Ms. Suchitra invested ₹ 20 lakh in the unit, and is providing employment to about 40 persons. She is earning around ₹ 2 lakh per month from this unit. She was also awarded a certificate by the Ministry of MSME.
- 3.3.3. Further, Ms. Suchitra has also started another enterprise for manufacturing vermicelli, with a capital of ₹ 20 lakh under the name of the unit "M/s Vamsi Traders". This unit is providing employment to about 15 persons and the income from this unit is ₹ 2.8 lakh per month.
- 3.3.4. This is the success story of Mr. Thamodharan, who underwent ESDP Training in Food Processing conducted by CED (Tamil Nadu) as a partner institution of **ni-msme**, Hyderabad, during August September, 2012.
- 3.3.5. Mr. Thamodharan has established a Badam Milk producing company with an investment of ₹3 lakh, and his monthly income is ₹15,000/-. He has now employed three persons, and has engaged more agents to sell his product.

3.3.6. Although Mr. Thamodharan, did not avail any bank finance, he was advised to avail financial assistance under one of the existing Government schemes such as, UYEGP, PMEGP and NEEDS for his expansion programmes.



3.4. Small Farmer Became an Entrepreneur

3.4.1. Mr. G. Laxma Reddy aged 35 years, Son of Mr. G. Sai Reddy, Karvena village in Boothpur mandal of Mahaboobnagar District. He got trained in Motor Winding & Pumpset Repair through the Entrepreneurship Skill Development Programme of National Institute of Micro, Small and Medium Enterprises (NI-MSME), organised by Participatory Rural Development Initiatives Society (PRDIS), Hyderguda, Hyderabad, a partner institution of NI-MSME.



- 3.4.2. Laxma Reddy is a marginal farmer with 5 family members. He has been cultivating since long but the income is not sufficient to run his family. Besides, the income was seasonal income not regular. Hence he wished to learn some off-farm skill which will help him to supplement his family income. He decided to learn motor winding and pumpset repair as it has more demand and he can work at it part time apart from his regular field work. Laxma Reddy was selected as one of the trainees for training in motor winding, conducted from 15th November to 26th December 2012. Subsequently he was awarded a certificate by **ni-msme** and PRDIS.
- 3.4.3. After the training, Laxman Reddy started working on motor winding at his own place and earning on an average ₹ 8,000 per month. Now he is very happy with this additional money and is cultivating his farm as well at his own village with out any financial problems.

3.5. Agriculture Labourer turned into an Entrepreneur

3.5.1. **Mr. G. Anjaneyulu** aged 35 years, has passed 10th class. He is the son of G. Buddanna, and lives in Thatiparthi village of Boothpur mandal, Mahaboobnagar district. He got trained in **Motor Winding & Pumset Repair** at the training Centre at Kothamolgara in Mahaboobnagar district through the Entrepreneurship Skill Development Programme of National Institute of Micro Small and Medium Enterprises (**NI-MSME**), organised by Participatory Rural Development Initiatives Society (PRDIS), Hyderguda, Hyderabad, a partner institution of **NI-MSME**.



- 3.5.2. Anjaneyulu is an agriculture labourer, belonging to BPL family. His family has four members: mother and two sisters. The availability of work is based on agriculture season; during the lean period they do not have any work so no income. Hence, he wanted to learn some off-farm skills in order to get livelihood during off seasons. He contacted the PRDIS coordinator. Anjaneyulu was selected as one of the trainees for training in Motor winding organised during 15th November to 26th December 2012.
- 3.5.3. Anjaneyulu has now set up a shop with his own investment and is working successfully, with 3 assistants, at Boothpur Mandal. He is earning ₹ 10,000/- per month.

3.6. Case Study of ESDP in Two-Wheeler Repairing Skills

- 3.6.1. Nanded is a district situated in the Marathwada region of Maharashtra. There lived a family consisting of four member's altogether. Sambhaji is the elder son of the family with one sister. Sambhaji is a daily wage farmer.
- 3.6.2. MITCON had released a advertisement for two-wheeler repairing training programme at Loha. Then the field staff of MITCON created awareness regarding the importance of Entrepreneurship Skill Development Programme on 'Two wheeler repairing' which is being conducted with the collaboration of **ni-msme**. Sambhaji joined the Programme in two-wheeler repairing at the Training Centre of MITCON. He did apprenticeship for two months to get a good hold on practical aspects, and subsequently started his own service centre in the name of Satguru Garej at Loha. Now he is giving economic support to his family.



3.7.. Case Study of ESDP in Cosmetology & Beautician Skill:

- 3.7.1. Karla Nirmala lives at Vetapalem village along with her husband and two children, who are studying 5th and 4th standard respectively. She has done graduation and Bachelor of Education as well. However, she could not get a Government teacher job. With her husband she started a business, Karla Handloom works, at Chirala. She used to look after the handloom work management. The business did not run properly because of not choosing the correct place. They incurred heavy loss in the business. Their financial condition became very tight. At this point she came to know about the ESDP in Cosmetology & Beautician skill, which was going to be conducted by ASSIST at Vetapalem Training centre.
- 3.7.2. Nirmala joined the course and worked hard to get perfection in what she was learning. The topics taught were shaping the eye brows, Facial, Bleaching, Applying henna, Bridal make-up, Mehendi, Pedicure, Manicure, Gold facial, Shanza facial etc. After completion of the course, she purchased the essential equipment in order to start a beauty parlour. In one of the rooms, she kept all the beauty parlour equipment.



3.7.3. Now, Nirmala is very happy and proud for having a better livelihood. She is very much thankful to the Ministry of MSME for providing this opportunity. She would like to express her gratitude to **ni-msme** and ASSIST for providing the training and giving the opportunity for getting a better livelihood opportunity in her life.

3.8. Case Study of ESDP in Motor Rewinding & pump set repairing Skill:

- 3.8.1. Subhani Babu is a native of Chinupalli village of Ballikurava mandal. He joined the ESDP in Motor Rewinding and Pumpset Repairing skill development programme conducted by ASSIST Vocational training centre.
- 3.8.2. During the training period, he was taught about various Electrical Tools, Electrical Theme about voltage resistance, Volts and current, Conductors and insulators, Soldering, Winding and repairs of ceiling fan, table fan, mixer grinding and iron box, Single phase motor winding and connecting, Three phase motor winding and connecting, Magnetism and Electro Magnetism, Advantages of AC and DC. After completion of the course the Ministry of MSME had issued a certificate for his future need.
- 3.8.3. After finishing the training, Subhani Babu started his own work shop at Martur and named it as "Subhani Motor Rewinding works". He is also giving opportunity for youth to work as an apprentice. He is very proud and happy now, as he has got not only good livelihood opportunity but is also able to provide employment to a few others. He is earning ₹ 18,000/- per month. He would like to express his sincere gratitude to Ministry of MSME, New Delhi, ni-msme, Hyderabad and ASSIST for providing the training.



3.9. Electrical Gadgets Repairing



3.9.1. K. Sandeep has been a business oriented person since his schooling days. He had always wanted to start his own business and provide support to his family, and give employment to some unemployed youth. He hails from a poor family consisting of father, mother, and two sisters. His father, who is a tailor, was barely able to support the family.

Sandeep came to know about **ni-msme** training programmes in Nalgonda. He enquired about all the courses offered by **ni-msme**, and selected electrical gadgets repairing course and completed the training successfully.

3.9.2. He started his own business and is earning $\stackrel{?}{\checkmark}$ 4,000 to $\stackrel{?}{\checkmark}$ 5,000 per month.

3.10. Cyber Café

- 3.10.1. D. Srinivasu lives in Ramachandrapuram, East Godavari, A.P. He has a bachelor's degree, and is a bachelor living with his parents.
- 3.10.2. Immediately after completion of the training programme, with the guidance of **ni-msme**, Srinivasu initiated action for opening a small venture. Without minding the hardship, he started his unit within two months from the date of the completing the skill training, by the name of S.L. Computers, in his residential area.



3.10.3. Before attending the training programme, Srinivasu had one computer. After the training, he received a loan of ₹ 1.50 lakh from the SBI. He purchased two more computers and started a computer servicing centre with ₹ 3 lakh capital investment. He is earning ₹ 25,000/- per month and has employed three more persons.

CHAPTER - 4

ACTIVITIES OF THE INSTITUTE

4.0. NATIONAL PROGRAMMES

4.2. SEMINARS AND WORKSHOPS

- 4.2.1. Fifty-eight seminars and workshops on different subjects were conducted during the year and 5,059 delegates had attended. A few of them are highlighted below.
- 4.2.2. Six workshops on Implementation of the Schemes of Ministry of Food Processing Industries, Govt. of India for the officials of Industries and Commerce Department, Govt. of Andhra Pradesh
- 4.2.3. Recognising the importance of food processing in addressing the issues of agricultural productivity and food prices inflation, the Govt. of India realised that growth impetus and value addition in the sector can be achieved only through effective decentralisation. Therefore the Government of India decided to transfer to the states the responsibility of selection of beneficiaries, implementation and monitoring of the identified programmes for 2012 as part of the centrally sponsored schemes. The programmes are proposed to be implemented through the National Mission on Food Processing (NMFP).
- 4.2.4. In conformity with the proposal by the Union Ministry of Food Processing Industries (MoFPI), the Commissionerate of Industries of the Govt. of Andhra Pradesh has decided, as a first step, to create awareness among its officers regarding the NMFP and the various schemes to be implemented through it. Four of the MoFPI-sponsored schemes have been transferred to the state for implementation through NMFP. They are as follows: the scheme for technology up-gradation/setting up/modernisation/expansion of food processing industries; scheme for supporting cold chain facilities for non-horticultural products; scheme for Human Resource Development (HRD); and the scheme for promotional activities.

4.2.5. The task of designing and conducting the awareness programmes has been entrusted to **ni-msme**. Accordingly six orientation workshops were organised on Implementation of the Schemes of the MoFPI, GoI, for the officials of the Dept. of Industries, GoAP. Each of the workshops was of two days duration. In all, 217 officers had participated in the six workshops. The delegates were of the ranks of DIC General Managers, Joint Directors, Industrial Promotion Officers, Assistant Directors and Deputy Directors.

- 4.2.6. The main focus of the workshop was on identification of issues in developing the guidelines for effective implementation of the schemes. The input coverage included a review of the status of and scope for development of food processing enterprises in Andhra Pradesh. Group discussions were incorporated in the programme design to give stronger focus to practical aspects. For this purpose, the participants were divided into sub-groups so as to facilitate in-depth discussions. Each group came up with concrete suggestions for developing the guidelines.
- 4.2.7. A one-day workshop on Pharma Networks–Innovation & Infrastructure Development was organised by the Institute jointly with the National Institute of Pharmaceutical Education and Research (NIPER), Balanagar, Hyderabad, at the **ni-msme** campus on 22nd November 2012. The workshop was sponsored by the Department of Pharmaceuticals, Ministry of Chemicals & Fertilizers, Govt. of India.
- 4.2.8. Dr. Ahmed Kamal, Director, Indian Institute of Chemical Technology (IICT) and of NIPER-H was the chief guest of the inaugural event. Delivering the inaugural address he said, Indian pharma industry is growing at a very fast pace. It is highly fragmented, and is facing a number of problems with respect to technology upgradation, effluent treatment, low R&D investments, inadequate infrastructure, and so on. The implementation of cluster development programme will help solve the problems to a large extent. As a pilot case, the Union government has made an allocation of ₹ 50 crore per cluster, and three clusters around Hyderabad have been identified for implementation. NIPER is also developing a centre for bulk drugs research, which will be enormously useful to the enterprises. By adopting a planned approach Indian pharma industry will join the ranks of world class drug units.

- 4.2.9. The themes deliberated upon in the workshop were: 1. Scope for Innovations and R&D in Pharmaceutical Clusters, chaired by Dr. A. Kamal, Director, IICT, Hyderabad; 2. Interventionary Instruments for Infrastructure Development in Pharmaceutical Clusters, chaired by Mr. V. Padmanand, International Expert on Clusters; 3. Policy Environment for Promoting Innovations in Pharma Clusters, chaired by Prof. Mukesh Gulati; 4. Interactions with Entrepreneurs, chaired by Dr. S.S. Vara Prasad, Consultant; themes 5 and 6 Panel discussions; Strategic Action Plan and Road Map were combined. The discussions were led by Dr. A.S. Rao, formerly with DSIR, and IIM, Ahmedabad, while Mr. Narayana Reddy, MD, Virchow Labs, Hyderabad; Mr. Padmanand; and Prof. Mukesh Gulati had participated.
- 4.2.10. Mr. M. Chandrasekhar Reddy, Director General of **ni-msme**, addressing the house during the valedictory function, had said that with a very good person to prepare a very good report, a very good agency, a very good consultant with whole-hearted commitment, this implementation will come off satisfactorily. **ni-msme** will take the lead in documenting the proceedings with NIPER, then get in touch with the pharmaceuticals department regarding the work for the three clusters.
- 4.2.11. International Women's Day was conducted on 11th March, 2013. A discussion meet was organized on the theme of "Women gaining momentum professionally and personally". Mrs. Chitra Ramachandran, IAS, Principal Secretary, Public Enterprises, Govt. of A.P. was the Chief Guest. As a public servant, she has narrated the issues concerning women. Padmasri (Dr.) Ananda Shankar, Dancer and Choreographer was the Guest of honour. She inspired and motivated the gathering by her exemplary speech. She shared her fight with the deadly physical ailment, the struggle with life, and her passion-dance. She made everyone to realise the inner strength practised by her. Mrs. Poonam Malakondaiah, IAS, Commissioner, Health & Family Welfare, Govt. of A.P. made an excellent and elaborate presentation on challenges faced by women. She also focused on the decline in the number of girl children and gave a call to improve it.

4.2.12. The workshop on Micro Business Centres for Prospective Entrepreneurs, sponsored by the Ministry of Housing & Urban Poverty Alleviation, was conducted on 27th and 28th March, 2013. Prof. P. Udaya Shanker, Director, School of Enterprise Management in his inaugural address explained the SEWA model which is a proven business model with low investment, simple turn-key operation which suit's any new franchisee with no prior business experience. In this model, a group will be formed and that group allows any one as a partner with leaders in the business and retail industries. He gave example of Bellary, Karnataka which was famous for stitching jeans and selling them, where once there was no business for tailors. He also gave another example of Lijjat Papad. He suggested those features to be incorporated and a model to be designed by the micro business centres to suit the entrepreneurs inclined to start up a small business.

- 4.2.13. A national workshop on Empowering the Youth through Enterprise Development was organised for youth including college students, unemployed youth and prospective entrepreneurs, on 18th March 2013. The workshop was sponsored by Andhra Bank, Indian Bank, Allahabad Bank and Indian Bank. Sixty-eight candidates from various parts of Andhra Pradesh had participated in the workshop.
- 4.2.14. An attempt was made to provide essential inputs like knowledge of various schemes, opportunities and support to those participants aspiring to acquire additional knowledge to start and maintain a business. The workshop was divided in to three technical sessions, viz., Scheme for the promotion of entrepreneurship development among youth; Business opportunities for youth; and Role of financial institutions in enterprise promotion. An eminent person in each technical session shared the knowledge to ignite the minds of the prospective young entrepreneurs. Reading material, supplementing the lectures and discussions, was also provided. It included the characteristics of the entrepreneurs and the soft skills required along with a list of key contact points for seeking information. All participants appreciated the programme and the benefits acquired from the technical sessions, and were satisfied with the clarifications of experts against their queries. The participants had also utilised the opportunity of networking with eminent speakers of the one-day workshop. They were benefited by the bankers' panel discussion and presentations. Participants expressed happiness and were delighted with the deliberations and discussions during the workshop.

4.3. INTERNATIONAL PROGRAMMES

4.3.1. Approval was accorded by the Ministry of External Affairs, Govt. of India for 20 international programmes for the benefit of 393 nominees from 73 developing countries who were granted ITEC/SCAAP/TCS fellowships. All these programmes were in four phases; 1st phase: 5 programmes (6th August-26th October, 2012); 2nd phase: 3 programmes (3rd September - 26th October, 2012); 3rd phase: 6 programmes (12th November 2012 - 4th January, 2013); and 4th phase: 6 programmes (21st January-15th March, 2013).

4.3.2. Prof. S. Satyanarayana, Vice Chancellor, Osmania University, Hyderabad, Chief Guest for the valediction of 1st and 2nd phases, had commended the painstakingly diligent efforts and the patience of the Director General of the Institute and the programme directors. He had observed that the programmes offered by **ni-msme** are demand driven and topically relevant. They are helping the country achieve its prime objective of accelerating the economic growth. Aimed at developing the expertise in enterprise creation and sustenance, **ni-msme** programmes are found to be immensely useful for application in the developing countries.

- 4.3.3. Mr. M. Chandrasekhar Reddy, Director General, **ni-msme** praised all the programme directors for their untiring efforts in organising the programmes, as a result of which the participants of all the programmes have given the ratings of 'very good' and 'excellent'. Further, he said that the participants appreciated the usefulness of the study visits which enhanced their clarity and understating of their subject. He also assured that every effort will be made to implement the suggestions made by the participants in the evaluation forms.
- 4.3.4. Two special programmes under TCS of Colombo Plan were approved by the Ministry of External Affairs. Ten nominees in the first programme (12th 23rd November, 2012) and eleven nominees in second programme (25th February 15th March, 2013) had attended.

4.4. RESEARCH AND CONSULTANCY PROJECTS

4.4.1. SFURTI Clusters: Interactive Meets with Khadi Artisans at Belur & Dharwad

- 4.4.1.1. **ni-msme** has been providing technical services for Belur and Hebballi Khadi clusters under SFURTI programme. Karnataka Khadi Gramodyog Samyukta Sangha, Bengeri is the implementing agency for the Belur Khadi cluster, whereas Dharwad Taluka Hebballi Kshetriya Seva Sangh is for Hebballi Khadi cluster. As per the cluster diagnosis, various interventions have been implemented for the development of the clusters during 2007-11.
- 4.4.1.2. An interactive meet in each of the clusters to review the impact was organised by inviting spinners, weavers, production managers, repairers and other members of the Khadi Institutions. Prof. K. Surya Prakash Goud, AFM, SED has participated in the meets organised on 24th July 2012 at Dharwad and on 25th July 2012 at Belur, respectively. He advised the implementing agencies and cluster development executives to consolidate the results and prepare a final documentation report.
- 4.4.1.3. During the discussions the artisans had expressed their happiness for the implementation of SFURTI and mentioned that the replacement of Charakas has reduced their physical work and production as well as quality of the product has been improved considerably. Some of the artisans were in a position to earn almost double the wage. The weavers, who were producing 4-6 metres of cloth earlier, were now producing 8-12 metres. A good number of weavers were in a position to earn Rs.700 Rs. 800 per week with average daily income of Rs. 125/-.
- 4.4.1.4. It is observed that the exposure visits arranged to Gujarat, West Bengal, Orissa, Tamil Nadu and Kerala for the benefit of the artisans helped them to understand the need for change and innovation in their working style and development of new value added products, where as the skill up-gradation programmes helped them to improve their skills and knowledge with respect to product quality and productivity.
- 4.4.1.5. In both the clusters, good number of value added products were introduced with vegetable dyeing and printing and also embroidery. The new products got positive response from the market and increased the profit margin. With renovation of Khadi emporiums, the space is being utilised effectively for product display and attracting the customers. The sales were increased by 40% at Bangalore whereas it was 100% at Dharwad. Apart from the above interventions, various other schemes like Janashree Bima Yojana, ICICI Lombard Health Insurance scheme and other State Government programmes were implemented for the benefit of the artisans and their family members.
- 4.4.1.6. During the interactive meets, the artisans felt that a new scheme has to be introduced for the benefit of the artisan family members and also to attract new artisans to Khadi activity. Some of them suggested establishing small enterprises for producing value added products, innovative marketing strategies for marketing of Khadi products and reorganisation of cotton preprocessing unit for regular supply of raw materials.

4.4.2. Cluster Initiatives in Uttar Pradesh

4.4.2.1. National Resource Centre for Cluster Development (NRCD) of **ni-msme** has initiated collection of cluster information, identification of cluster specific issues and scope for development of clusters in the state of Uttar Pradesh. The clusters include artisan based clusters like Nagina wood craving, Meerut band baja, Sultanpur Leather, Bijnour Block Printing, Varanasi Meenakari, as well as industrial clusters like Rampur and Pilibhit Rice Milling, Bareilly Essential Oils, Mau Powerloom, Amroha Textile Waste Processing and Battery/Inverter Manufacturing clusters.

- 4.4.2.2. **ni-msme** cluster team Prof. K. Surya Prakash Goud, Mr. Hari Shanker and Mr. Rizwan Ahmed along with experts from Foundation for MSME Clusters viz., Mr. A.S.K. Sharma, Mr. K.L. Sarkar and Mr. Sagnik Lahari visited all the clusters during 3rd 30th Sept 2012. They had interacted with the General Managers of District Industries Centres, representatives of industry associations, NGOs, entrepreneurs, bank officials, and other important cluster stakeholders.
- 4.4.2.3. During the visit the team members had interacted individually with the entrepreneurs and also organised small group meetings for collection of relevant information. The discussions concentrated on genesis of cluster, cluster products, issues related to technology, marketing, infrastructure, finance and human resource development. The officials of Government of Uttar Pradesh have actively participated in the discussions and provided constructive suggestions for development of the clusters. Based on the observations of the team members and interactions held with the stakeholders, a tentative action plan was prepared for each of the cluster. Some of the action plans like Meerut Band Baja, Nagina Wood Craft, Bijnour Block printing, Rampur Rice Milling and Moradabad Chandi paper cluster were validated by inviting the officials of industries department, NGOs, industry associations, and other cluster stakeholders.

4.4.3. Activities in Handloom Clusters

- 4.4.3.1. **ni-msme** has successfully implemented the Integrated Handloom Cluster Development Programme in Barabanki and Mubarakpur clusters. As per the cluster needs and part of the interventions, common facility centres (CFCs) were established in both the clusters. Looms, testing equipment, dyeing facility, block printing, etc., were provided in the centres. In order to utilise and manage the facilities effectively, a consortium was formed in both the clusters. Now the members of the consortia were using the machines for their requirement and encouraging other weavers to utilise the same.
- 4.4.3.2. Prof. Suryaprakash Goud, Faculty of **ni-msme** visited the CFC at Barabanki and Mubarakpur to interact with the members of consortia and other weavers and understand their requirements for effective functioning of CFCs. Along with Mr. Hari Shanker, Technical Resource Person, Prof. Goud discussed with Mr. Fakir Ali, Mr. Tajuddin, Mr. Intiyaz Ali, Mr. Figa Waris, Mr. Shabbir Ali and other members regarding regular operation of equipment at the Barabanki CFC. The members have shown some of the products of block printing and their future plans for revenue generation to meet the recurring expenditure. Prof. Goud and the CDE of Mubarakpur cluster, Mr. Rizwan Ahmed, discussed with the consortia members namely Mr. Kamarullhuda, Mr. Serajullah, Mr. M. Afzal, Mr. Shabir, Mr. Safi Ahmed, and Mr. Shahid regarding effective utilisation of the machinery. It was also suggested to help women SHGs to manufacture new products with value addition. The members said that a training programme was to be organised on testing equipment for interested weavers and other stakeholders with the support of equipment suppliers.
- 4.4.3.3. Prof. K. Surya Prakash Goud, along with Mr. Rajesh Pratap Singh Yadav, General Manager, District Industries Centre met Mr. Pranjal Yadav, District Magistrate of Azamgarh to apprise about **ni-msme** activities in the state particularly interventions in the Mubarakpur handloom cluster and preparation of diagnostic study report (DSR) of Jahangunj powerloom cluster. He explained about interventions completed in Mubarakpur cluster and impact of interventions. Major interventions like formation and strengthening of SHGs, training on dyeing, participation in national exhibitions, development of new products, and establishment of common facility centre were highlighted. During the discussions, the Magistrate enquired about the development of new and innovative products in the textile sector and suggested creation of market for the same. Later, Prof. Goud requested to support the Mubarakpur consortium for conducting training programmes with the support of DRDA and NABARD. The Magistrate mentioned his experiences relating to Azamgarh power loom and handloom products, and expressed his willingness to support the sector in all respects.

4.4.4. Evaluation of NBCFDC Schemes in the Union Territory of Pondicherry

- 4.4.4.1. The Project was sponsored by National Backward Castes Finance and Development Corporation, New Delhi. The Pondicherry Backward Classes and Minorities Development Corporation Ltd.(PBCMDC), acting as the State channelising agency of NBCFDC, from its inception till the end in November 2012, rendered laudable services to 3,548 beneficiaries of the backward class communities of Pondicherry through the implementation of NBCFDC funded term loan scheme covering 1,411 persons; education loan covering 1,785 persons effective from 2001, and micro credit scheme covering 352 persons from 1st April 2009 onwards, as revealed by the study undertaken at the instance of the NBCFDC, New Delhi.
- 4.4.4.2. The study covered a sample of 177 beneficiaries of the term loan scheme, 86 beneficiaries of the micro finance scheme and 132 beneficiaries of the education loan scheme. The total of 263 beneficiaries of term loan and micro finance loan beneficiaries were engaged in twenty-two different income generating activities. The study was completed and the report submitted to NBCFDC. The project was coordinated by Prof. N.R. Prasad Reddy, Faculty, School of Enterprise Development.

4.4.5. Socio-Economic status of the entrepreneurs and work force of Textile and Apparel manufacturing Clusters in Solapur, Bhiwandi & Malegoan

- 4.4.5.1. A study to know the present status of textile and apparel manufacturing enterprises with reference to socioeconomic status of the entrepreneurs and work force located at Solapur, Malegaon and Bhiwandi in the
 State of Maharashtra was taken up during the year. The other objectives of the study included developing
 strategies for increasing the turn over, establishing new marketing channels, exploring new markets,
 enhancing production efficiency, attending environmental issues, etc.
- 4.4.5.2. The study has been conducted by the **ni-msme** faculty with the support of professionals experienced in the UNIDO Cluster Development Methodology. The information pertaining to cluster enterprises, business operations, critical bottle necks that are hindering development of the clusters, and other important data has been collected to analyse the forward and backward linkages of the industry. The researchers had also met the individual public and private service and supporting institutions to analyse their services and identify gaps, to plug the same through interventions. Further the strengths, weaknesses, opportunities and challenges of each cluster were also analysed.
- 4.4.5.3. Based on the data and inputs from various interactions, cluster specific action plan has been prepared along with the scheduling of the activities for development of the clusters based on the problem analysis and then validated the same with the cluster enterprises and other development agencies involved in the clusters.

4.4.6. Evaluation Study of Export Promotion (Training Programme on Packaging for Exports) **Scheme**

- 4.4.6.1. The Office of the Development Commissioner (MSME), Ministry of Micro, Small and Medium Enterprises, Government of India, has entrusted to **ni-msme** the task of carrying out a study of its scheme entitled "Evaluation Study of Export Promotion Scheme (Training Programme on Packaging for Exports)" a scheme that was being implemented by its field offices, viz., MSME-DIs for the benefit of both the existing as also prospective entrepreneurs across the country engaged in overseas export of their products with accent on export packaging of their products on par with global standards. The objective of the evaluation was to have an insight into the extent of impact of the scheme in achieving the objectives set forth as well as to try and find ways of sustaining continued impact in the days to come by suitably carrying out slight modifications of procedures in vogue, where need be.
- 4.4.6.2. Based on the information pertaining to the training programmes conducted by MSME-DIs, **ni-msme** had conducted a pilot study at Hyderabad and Tanuku of Andhra Pradesh with a view to getting acquainted with

the modalities / modus operandi to be pursued for successful completion of the task assigned, and finalised the questionnaires designed for collecting the primary data from the target group viz., participants, officials of MSME-DI and concerned IIP faculty. Simultaneously focus was given to collecting the secondary data as found necessary for the study. The study team interacted with the participants of the training programmes as per the sample size, the Directors concerned of MSME-DIs, Programme Directors/ Course Coordinators, IIP faculty concerned at 27 locations in the country apart from talking to representatives of select industry associations concerned for the purpose of collecting primary data.

4.4.6.3. The data collection was in progress and the report with findings was expected to be completed during the following year.

4.4.7. Director KIBT visits ni-msme

4.4.7.1. Mr. Steven Kirui, Director, Kenyan Institute of Business Training accompanied a delegation on trade mission to Hyderabad. In this regard a brief meeting was held on 6th Sept 2012 with the faculty for exploring the areas for possible collaboration. The Director, KIBT suggested a few initiatives i.e., Training of Trainers, Cluster Development and faculty exchange programme, to be taken up by **ni-msme**. Director General Mr. M. Chandrasekhar Reddy assured that joint collaboration work would be taken up at the earliest.



4.4.8. Visit of Kenyan Trade Mission

4.4.8.1. A 15-member delegation on trade mission to India visited Hyderabad during 10-11 September, 2012 to hold B2B meetings with entrepreneurs. In this connection **ni-msme** coordinated the meetings with the entrepreneurs of Hyderabad. The delegation was mainly interested in the lines of personal care products, paints, plastics, FRP, packaging and others. Mr. Sumiyuki Otsuki, Development Economy/GIS in Japan Development Institute (JDI) and Mr. Chimpal Rauniar, led the delegation. The delegation visited the CIPET and Plastics Packaging and FRP units located at Cherlapally industrial area on 10th Sept 2012 and held one-to-one meetings with the entrepreneurs. They also held discussions with the officials of CIPET to enter into collaboration in skill development training in plastics.

- 4.4.8.2. On 11 September, 2012 a B2B meeting was held, where in 20 entrepreneurs of ALEAP, Jeedimetla Industries Association etc., had presented their products and capabilities in paints, personal care products, engineering industries, herbal and other products. Ms. K. Rama Devi, President of ALEAP also attended the B2B meeting and addressed the Kenyan delegation, and assured of ALEAP help in starting up the ventures.
- 4.4.8.3. Director General of **ni-msme** Mr. M. Chandrasekhar Reddy also addressed the participants. After completion of the meeting, Mr. Sumiyuki Otsuki, leader of the delegation expressed happiness with the arrangements. He complimented the Director General and the Faculty of **ni-msme** for organising such useful visits and meetings at such short notice. The delegation also visited the Federation of Andhra Pradesh Chambers of Commerce & Industry (FAPCCI) office in the afternoon. They conducted an elaborate meeting with the Kenyan delegation chaired by Mr. Srinivas Ayyadevara, Senior Vice-President, involving more than 25 entrepreneurs engaged in manufacturing different products. After the formal meeting the delegates had one-to-one meeting with entrepreneurs relevant to them and held discussion on possible business tie-ups.

4.4.9. Visit of Nepal Delegation

- 4.4.9.1. A thirteen-member Nepal delegation led by Mr. Kabir Kumar Chitrakar, Senior Programme Officer, GIZ, and Mr. Chakrapani Timalsina, GIZ visited **ni-msme** on 8th November 2012 as part of their study tour. The objective was to understand the best practices adopted by the SME sector in India. The delegates from the following organisations were present and participated in the discussions.
- 4.4.9.2. Ministry of Industry (MoI), Industrial Enterprise Development Institute (IEDI), Federation of Nepalese Chamber of Commerce & Industry (FNCCI), Youth & Self-Employment Programme of Ministry of Finance (YSESEF), Council for Technical Education & Vocational Training (CTEVT), Cottage & Small Industries Development Board (CSIDB), and GIZ, Nepal, and entrepreneurs from food industry.

4.4.10. Activities of Resource Centre for Traditional Paintings in Handicrafts (RCTP)

- 4.4.10.1. The RCTP of **ni-msme** had organised a summer art camp at its premises. The duration of the camp was from 23-04-2012 to 31-05-2012. During this art camp, the learners had the opportunity to get acquainted with Indian traditional art, learning from the basics.
- 4.4.10.2. The main aim of the art camp was to give expose the participants to Indian traditional Paintings like Madhubani and Worli. There was tremendous response from the students and parents. In all 27 students had participated in this art camp. It was a good experience and very encouraging for planning similar events in future.
- 4.4.10.3. After completion of the art camp, the traditional paintings drawn by the ART CAMP STUDENTS were displayed during the visit of Sri C.K Mishra, IAS, Joint Secretary (MSME). RCTP was updated and displayed all the traditional paintings with their related history including the artist's details. The national and state level award winners' details were also displayed.
- 4.4.10.4. Shri C.K Mishra I.A.S., Joint Secretary of MSME Government of India, during his recent visit to **ni-msme**, along with Director General Prof. M. Chandra Sekhar Reddy, Shri NVNS. Dev Director (SED) visited RCTP.

Director (SED) explained to the Joint Secretary about RCTP and the display of traditional paintings. He also verified the documentation reports of Traditional Paintings. He expressed satisfaction over the display of selected traditional paintings as well as the background information. He appreciated the students' paintings, which were on display and also the traditional paintings of the artists.

- 4.4.10.5. Discussions were held with artists about art camps for artisans and conducting art exhibitions to promote the traditional paintings. The display included the details such as rate tags, artists name, and paint work details. As part of promotional activity, contact was made with the officials of similar organisations like Lepakshi and marketing opportunities were discussed. These discussions resulted in an assurance from Lepakshi for purchase of art pieces from RCTP (Gond Art, Patachitra and Worli)
- 4.4.10.6. The members of RCTP also met Sri Srinivasan, Development Commissioner (handicrafts) and got an opportunity to discuss about the art work of RCTP.
- 4.4.10.7. The RCTP had organised another Art Camp and Exhibition with Traditional Artisans in collaboration with Tourism Plaza, GMC Balayogi Paryatak Bhavan, Greenlands, Begumpet, Hyderabad from 29th June to 5th July 2012. The programme was inaugurated on 29th June 2012 at 4.00 PM by Smt. Chandana Khan, IAS, Special Chief Secretary and Chairperson, YAT&C Dept. and Shri Anjaneya Reddy, IPS (Rtd), was the Guest of Honour.
- 4.4.10.8. In this connection, the following nine artists with different traditional art background were invited. They displayed their traditional paintings and also attended to art work at the camp by using the eco friendly materials and demonstrated.

4.4.10.9. The aim of the programme was to promote various types of traditional paintings of our country with the aim of encouraging the artists art work. At the same time, it helped as a platform for providing marketing opportunity for their art products. The artisans, who were from other states were provided board and lodge at the **ni-msme** campus.



- 4.4.10.10. The programme was also witnessed by the social activist Ms Sue Freeman from Australia along with her team accompanied by Mr. Sreenevasan, Asst. Director of Handicrafts. She highly appreciated the art camp and was enthusiastic about Indian culture and traditional art.
- 4.4.10.11. The programme was highly appreciated by the DCH, Nampally, Cheneta Bhavan, Hyderabad. The programme was published in reputed newspapers like Sakshi and Hans India. TV channels like Sakshi, Gemini News and ETV-2 interviewed the artists and telecasted the same. (The copies of news paper clippings and Photographs are enclosed.)
- 4.4.10.12. The artisans received orders from reputed art and craft societies like Kalanjali, Mangalarm Art & Craft show room (Banjara hills) and the Uttarakhand division of AP Paryatak Bhavan.

4.4.11. Activities of Intellectual Property Facilitation Centre (IPFC)

4.4.11.1. Steering Committee Meeting: The fourth meeting of IPFC Steering Committee was held on 30th April 2012. Reviewing the progress made by the Centre, the Director General, who chaired the meeting, suggested bringing awareness of IPFC services among the MSMEs so that they may be utilized to the maximum extent.

CHAPTER - 5

USE OF OFFICIAL LANGUAGE

- 5.1. Under the **Hindi Teaching Scheme** 18 employees were nominated for correspondence course that was conducted from January 2012 to May, 2012. However, only 12 employees had attended the Prabodh examination held at the Kendriya Vidyalaya, Hyderabad, and all the 12 employees have passed the examination.
- 5.2. On 14th September, 2012 the Hindi Day celebrations were observed. During 13-16 September, 2012 workshops and competitions for writing in Hindi were held.



- 5.3. Twenty-two employees (officers and staff) took the Praveen/Pragya examinations held on 18th and 24th November, 2012 respectively, of whom 12 have passed.
- 5.4. Two employees were nominated for "Basic Training Programme on IT Tools of Hindi Computer" which was held at Bharath Dynamics Ltd., Hyderabad from 19th to 23rd November, 2012.
- 5.5. Under Hindi Teaching Scheme, the Hindi classes for Pragya had commenced from 30th January, 2013 on alternate days. The Assistant Director, Hindi Teaching Scheme, Govt. of India and Hindi Pradhyapak, Smt. Nilbha Tiwari were extending their services.

CHAPTER - 6

VIGILANCE ACTIVITIES

- 6.1. Dr. C. Rani, Director i/c., School of Entrepreneurship and Extension was the part-time Chief Vigilance Officer of the Institute. She had attended to all the vigilance related activities.



1. Report on the Financial Statements:

We have audited the accompanying financial statements of National Institute for Micro, Small and Medium Enterprises (ni-msme) ("the Institute"), which comprise the Balance sheet as at 31st March 2013 and the statement of income Expenditure for the year then ended and a summary of Significant Accounting Policies and other explanatory information.

2. Management Responsibility for the Financial Statements:

3. Auditor's Responsibility:

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with the Standards on Auditing issued by the Institute of Chartered Accountants of India. Those Standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatements.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditors' judgment, including the assessment of the risks of materials misstatement of the financial statement, whether due to fraud or error. In making those risk assessment, the auditor considers internal control relevant to "the Institutes's" preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances.

An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of the accounting estimates made by the management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

- 4. Our comments on the financial statements for the year are as follows:
- (a) Balances appearing under Debtors, Creditors, advance received / paid are subject to confirmation/recconciliation and consequential adjustments, the impact which on these statements are not quantifiable by us.
- (b) Reference is invited to Note 4.2 of Schedule 25 regarding demand from Commissioner of Customs, Central Excise and Service Tax for Rs. 387.99 Lacs towards payment of Service Tax for the period from 2004-05 to 2008-09 and amount of Rs.388.05 Lacs as penalties. Further demand of Rs. 77.92 Lakhs for the year 2009-10, Rs. 2011-12, have also been raised by the Commissioner of Customs, Central Excise and Service tax. "The Institute" has filed an appeal before Hon'ble Customs; Excise & Service tax Appellate Tribunal, Bangalore. In the absence of any provision for the same, we are not in a position to comment on the ultimate liability that may arise at a later date and its impact on the financial statements.
- (c) Out of total landed area of 107 Acres Guntas 22 owned by "the Institute" encroachments have been identified to extent of Acres 58 and Guntas 2. "The Institute" is sated to have made relentless efforts including civil suit in the competent court of law, though secured positive verdict in favor of "the Institute", but could not regain the encroached land due to law and order problems, as per the advice of District collector, Hyderabad. Hence it is stated that "the Institute" is ultimately in actual possession of land area of Acre 49 and Guntas 20 only.
- (d) (i) Internal controls and systems are required to be strengthened in respect of programs conducted by outside agencies on behalf of "the Institute", particularly IT programs where the fees are collected in cash by those agencies and remitted to "the Institute"
 - (ii) The scope of Internal audit coverage needs to be enhanced in view of the increase in the activities of "the Institute", particularly in the areas of expenditure incurred on various programs.

- (iii) Sundry Debtors includes amounts to be received from "other Clients" of Rs. 176.04 Lakhs pending receivable for more than three years, which in Our opinion is doubtful of realization and provision for the same is to be made.
- (e) According to the information and explanations given to us, physical Verification of the assets of "The Institute" were not carried out during the Year. "The Institute" has also not updated the Fixed asset register. In the Absence of the above information, we are not in position to comment on the differences/discrepancies and their impact on the financial statements.
- (f) As per information given to us "The Institute" has made provision of Rs.88.64 Lakhs towards liability of Earn encashment and Rs. 146.92 Lakhs towards Gratuity provision, relating to period up to 1988, which is The absence of full information the correctness of the same could not be checked.

5. Opinion:

Subject to our comments given in paragraph 4 above, we report that:

In our opinion and to the best of our information and according to the explanations given To us, the aforesaid financial statements give the information required by the Act, in the Manner so required and give and true view in conformity with accounting principles Generally accepted in India.

SCHEDULE 24 – SIGNIFICANT ACCOUNTING POLICIES

1. ACCOUNTING CONVENTION

The financial statements are prepared on the basis of historical cost convention, unless otherwise stated and on the accrual method of accounting.

2. INVENTORY VALUATION

Inventories are valued at lower of market price or cost basis.

3. FIXED ASSETS

Fixed assets are stated at cost of acquisition inclusive of inward freight, duties and taxes and incidental and direct expenses relating to acquisition.

4. DEPRECIATION

Depreciation in respect of the Assets: Buildings, Books and Periodicals has been charged on written down value at the rates as prescribed by CPWD Rules and the rest of the assets are depreciated at the rates prescribed by Income Tax Act, 1961.

In respect of additions to fixed assets during the year, depreciation is considered for full year.

Assets valuing Rs.5,000/- or less each are provided full depreciation.

5. GOVERNMENT GRANTS

Revenue grants received from Government towards recurring activities are accounted as Income on accrual basis.

Grants related to specific fixed assets are shown as a deduction from the Gross value of the asset concerned in arriving at its book value.

SCHEDULE 25 – NOTES TO ACCOUNTS

1. GRANTS

- 1.1. Unspent grant of Rs.32,39,456/- towards the capital (non-recurring) expenditure on Resource Centre for Traditional Paintings in Handicrafts (RCTP) and Rs.38,69,120/- towards revenue (recurring) expenditure relating to activities was brought forward from 2011-12 and the same was utilized during the year.
- 1.2. An amount of Rs.11,92,46,392/- was to be received from different Ministries for various activities executed during the year.
- 1.3. Recurring including amounts receivable and unspent carried forward from 2001-12 & non-recurring grants received during the year including unspent grant brought forward from previous year, expenditure incurred and unspent balance carried to next year are indicated as below:

2. RETIREMENT BENEFITS

- 2.1. Liability towards gratuity payable on death/retirement of employees is provided on accrual basis.
- 2.2. Provision for accumulated leave encashment benefit to the employees is made on accrual basis and computed on the assumption that employees are entitled to receive the benefit as at each year end.
- 2.3. Pursuant to the decision taken by the Executive Committee in the 5th meeting held on 1st February, 2010, accumulations under the fund relating to the Employees retirement benefits were transferred to the separate fund account and the same is administered by a Committee called "Retirement Benefits Fund (RBF) Committee."

3. OTHERS

Land includes an area of 43 acres 8 guntas acquired from private parties at the rate of Rs.4,000/- per acre as directed by the Government of Andhra Pradesh. However, it was enhanced to Rs.12,000/- per acre by the City Civil Court and the differential amount of Rs.8,000/- per acre was deposited into the court by the Institute. This additional amount was capitalized as part of the cost of land. However, on appeal preferred by the Institute before the Hon'ble High Court of Andhra Pradesh, on the advise of the Government of India, the High Court reduced the rate per acre by Rs.2,000/- to Rs.10,000/- per acre. The Hon'ble High Court also directed the Special Deputy Collector to collect the differential amount of Rs.2,000/- per acre (totaling to Rs.1,17,648) from various parties to whom the amounts were paid earlier and make over the same to the Institute.

4. CONTINGENT LIABILITIES

No provision was made for Rs.6,40,861/- pertains to earlier year towards liability for conveyance allowance payable to employees as the matter is pending for final judgement in the Hon'ble High Court of Andhra Pradesh. Further, notice was given to the employees for discontinuance of conveyance allowance with effect from 13.10.1992.

Disputed demand from the Commissioner of Customs, Central Excise and Service Tax for Rs.3,88,03,987/towards payment of service tax for the period from 2004-05 to 2008-09 was received on 28.4.2010. In this connection, an Appeal U/s 86(1) of the Finance Act, 1994 was filed before South Bench of the Customs, Excise and Service Tax Appellate Tribunal, Bangalore. The Appeal was heard by the Bench 18th July, 2012. The Bench considering the submitted facts passed an interim order directing the Institute to deposit an amount of Rs.15.00 lakh and the same was deposited.

5. CAPITAL COMMITMENTS

Estimated value of contracts remaining to be executed on capital account and not provided for (net of advances) was Rs.Nil (Previous year Rs.Nil).

6. CURRENT ASSETS, LOANS AND ADVANCES

In the opinion of the Management, the current assets, loans and advances have a value on realization in the ordinary course of business, equal at least to the aggregate amount shown in the Balance Sheet.

7. TAXATION

In view of there being no taxable income under Income-tax Act 1961, no provision for Income Tax has been considered necessary.
